1. **Roll Call**: Called to order at 9:10 am by Chairman McDaniel; it was noted that a quorum was present.

- a) **COG-COA Implementation Grant:** Southeast CT Council of Governments is submitting a grant for the Comprehensive Operating Analysis. The grant will enable SEAT to implement the Nelson-Nygaard COA. Stephanie Molden, SCCOG has done an excellent job facilitating the initiative and is essential to SEAT as the staff is limited on time and resources. Support letters were obtained by many organizations and towns, and a friendly reminder was put out to those who have not responded yet.
